On January 12, 2022, the Maryland General Assembly will convene for the 443rd session of the General Assembly. Every session presents an opportunity to educate lawmakers and tell the many positive stories being driven by job creators to advance economic success and create Maryland jobs. It also affords us the opportunity to raise the challenges being faced by employers and to work collaboratively toward solutions that make Maryland a better place to live and work.

The Maryland Chamber of Commerce's **Meet the State** event is the premier, early-session gathering of legislative and state government leaders. Being held virtually for the second year, the two-hour session will bring together policymakers and business representatives to discuss critically important public health and economic issues as we work to overcome the pandemic and remain on the road to recovery.
